

Terms and Conditions

Open to UK mainland residents only, except employees of the Promoter (The Mall, Luton), Capital & Regional PLC, and their associated, affiliated or subsidiary companies, their families, agents or any other person(s) connected with the competition, including third party promotional partners. Minimum age restriction 17+, full UK driving licence will be required

- Competition opens on Thursday 1st February 2018, or thereafter, and closes on Monday 12th February 2018 at 5pm (the Closing Date). Entries received after the Closing Date will not be counted.

- The receipt should be taken to the Ask Me Point.
- Entrants should complete an entry form, filling out all questions in an honest and truthful manner.

- Entrants may enter the promotion multiple times, they do not have to complete a new entry form, instead their receipt details should be added to their existing form held at Ask Me Point. Each receipt will count as one entry.
- On Tuesday 13th February, 10 finalists will be randomly chosen from all entrants to be taken to the live promotional final.
- Finalists will be contacted via the contact details they have provided. All reasonable endeavours will be made to contact the finalists during the specified time (13th midday on 14th February 2018). If a finalist cannot be contacted or is not available, the Promoter reserves the right to re-draw another finalist from the valid entries that were received before the Closing Date.
- Finalists must complete a Health and Medical questionnaire which The Mall will provide. Without completion of this questionnaire the finalist will not be able to take their place during the live event. All completed questionnaires should be with the "promoter" by 1pm on Wednesday 14th February 2018.
- The live activity will take place on Thursday 15th and Friday 16th February 2018 between the hours of 8am to 6pm, and from 8am 3pm on Saturday 17th February. If an entrant cannot commit to this time then their place will be voided. An entrants place is not transferable.

Live event

During the 3 days of the live event, finalists will be competing to win a new car.

The prize is Toyota AYGO x-play, 5 door in solid red, 2018 plate, worth £10,905 from Steven Eagell Luton. This comes with a 5 year warranty, 1 year AA roadside assistance and a full tank of petrol.

- Vehicle will need to be collected from the dealership, Steven Eagell, Luton, or delivery may be able to be arranged to a local address. If the winner wants the car in February they will be able to take delivery, however this will be a 67 plate. If the winner waits until March they will be able to drive away a brand new 2018 registration. The prize does not include insurance and the winner must arrange this themselves. The Mall has not arranged insurance and so it is the winner's responsibility. After the winner has the car in their possession they are liable for the payment of all tolls, congestion charges, parking, road traffic fines or costs for any additional fuel beyond the tank provided as part of the prize. Excludes any other costs connected to the prize.
- Each finalist will place 1 hand on the hand prints located on the car. If they take this hand away from the car then their participation in the competition will cease. Event staff on site will determine if this is the case and are the final judges.
- Magnetic hand prints will be located on car with each person having a left and a right in front of them. They have to maintain contact with the car at all times. If you decide to swap hands you should indicate to an event judge who will stand

- over you whilst you swap. Any attempt to swap without a judge being present may result in the finalist being disqualified.
- During the day pre agreed food and toilet breaks will be given. Any breaks additional to this, and not agreed by The Promoter, will lead to an entrant's disqualification.
- Finalists must be on site at The Mall, Luton by 8am on 15th, 16th and 17th February. Finalists will be automatically disqualified if they are not on site and ready to participate by 8.30am. The Promoter takes no responsibility for finalists who are late. All finalists will be standing with one hand on a mark on a car located in The Mall, Luton from 8.30am to 6pm (Thursday & Friday) and 8am 3pm (Saturday). If a finalist has medical reasons as to why they cannot stand, i.e. in a wheel chair they can of course use such a medical aid. They may be required to show evidence of disability.
- Each finalist will be able to take comfort breaks. On Thursday and Friday each will be able to take 3 x 15 minute breaks and on Saturday 2 x 15 minute breaks. To take these breaks the finalist should speak to a judge and once the judge has agreed the 15 minutes will commence.
- If a finalist is late back and do not have their hand in position when The Promoter says, they will lose their place in the competition. The Promoters time keeping is the rule. This will be done via a stop watch.
- All finalists will be allowed to eat and drink with their free hand whilst participating. They will also be allowed to use items such as phones to make calls or access social and digital media
- If a contestant loses contact due to events beyond their control i.e. arm pulled off by shopper etc then the judges will take into account the situation and decide if the contestant should still be able to take part in the activity.
- St John's Ambulance will be on site during the live activity, it is the responsibility of the entrant to advise them if they are feeling unwell.
- The "promoter" accepts no responsibility for ill health that may occur to the contestants due to their taking part within this activity.
- The winner will be the person who keeps their hand on the car the longest.
- If 2 or more contestants still have their hand on the car at 3pm on Saturday 17th February 2018 then a tie break situation will happen.
